# OFFICIAL RULES FOR MERCURY REPOWER CAMPAIGN GIVEAWAY

NO PURCHASE NECESSARY TO ENTER OR TO CLAIM A PRIZE. VOID WHERE PROHIBITED BY LAW.

By entering, all participants agree to be bound by the following terms and conditions ("Official Rules").

# Eligibility:

To be eligible to enter and win you must be: (a) a legal U.S. resident (excluding Puerto Rico, U.S. territories and possessions); (b) 18 years or older as of the Entry Period and (c) reside in the United States as of the Entry Period. To be eligible to win the Grand Prize, the winning entrant must also own a boat that is suitable for the safe installation and operation Winning entrant must also own a boat that is suitable for the safe installation and operation of the selected engine (between 2.5HP and 250HP) as further explained below. ## Entry Period

# How To Enter:

To enter the Giveaway, eligible entrants will scan the QR code and complete the webform on the Giveaway landing page during the Entry Period. Only one entry per person is allowed. Multiple entries from the same person will be disqualified.

The name of the person submitting the Giveaway entry must be the name of the person who owns the email account; otherwise, entry may be deemed void. In the event of dispute over the identity of a potential winner, online entries will be declared made by the authorized account holder of the email account submitted at the time of entry, and potential winner may be required to provide identification sufficient to show that he/she is the authorized account holder of the email account. Winners will be notified by email communication. Winners will have ten (10) days to reply to the email and claim their prize. The Grand Prize winner will select the size of the engine to be awarded, subject to the following limitations:

- Eligible engines consist of Mercury Marine outboard engines between 2.5HP and 250HP, excluding Verado and Avator brand engines.
  The winner must own a boat as of the end of the Giveaway Period that is suitable for the size of the engine selected. The Grand Prize Winner and Sponsor shall work together to determine the size and suitability of the engine for the Grand Prize Winner's boat.
